



Environmental Standard for Commercial Cleaning Services (GS-42) Certification Fee Schedule

Effective April 15, 2009

Green Seal's fees are based on the number of accounts cleaned by the service, the applicant's annual revenue, and other factors. An *evaluation* is necessary to verify that your cleaning service meets the standard. Also included is a review of labeling and any other marketing or promotional materials that feature the Green Seal Certification Mark. *Monitoring* is done periodically to ensure continued compliance with the standard. The monitoring fee begins to accrue from the date of certification and is due no later than the anniversary date of certification. Out-of-pocket costs for the audit, such as for travel, are in addition to these fees.

The fee schedule below reflects the basic cost of certifying cleaning services under a contractual application and license agreement with Green Seal, Inc. The base fee below includes auditing one account; additional account audits may be required and incur additional fees, as indicated below.

Tier I (Annual sales revenue \$5 million or over)

Evaluation Fee:	\$9,350
Monitoring Fee:	\$9,350

Tier II (Annual sales revenue \$1 million to \$5 million)

Evaluation Fee:	\$8,300
Monitoring Fee:	\$8,300

Tier III (Annual sales revenue \$500,000 to \$1 million)

Evaluation Fee:	\$6,750
Monitoring Fee:	\$6,750

Tier IV (Annual sales revenue \$200,000 to \$500,000)

Evaluation Fee:	\$6,050
Monitoring Fee:	\$6,050

Tier V (Annual sales revenue less than \$200,000)

Evaluation Fee:	\$4,950
Monitoring Fee:	\$4,950

Account Audit Requirements

The account audit requirement is based on the number of accounts cleaned by the service provider. Green Seal reserves the option to visit up to a maximum of 5% of the accounts cleaned.

Additional Account Audits

Additional fees will be added for each account audited after the initial account. These fees are based on the applicant's annual revenue.

Tier I & II (Annual sales revenue \$1 million or over)

Evaluation Fee:	\$2,600
Monitoring Fee:	\$2,600

Tier III, IV and V (Annual sales revenue less than \$1 million)

Evaluation Fee:	\$2,000
Monitoring Fee:	\$2,000
